## The conditions of their engagement by PMU-DTE would be as follows:

1. The engagement will be on deputation basis, without any provision for payment of deputation allowance.

2. They will render services at the Project Management Unit, Directorate of Technical Education and continue to draw salaries at their respective institutes against their incumbent post.

The engagement will be, initially for a period of 1 year from the date of their joining.

Their performance would be reviewed every quarter/half-yearly basis. Based on which further engagement would be decided.

You are therefore directed to relieve the concerned teacher of your institution to take up the position as SPOC.

You are hereby permitted to appoint a substitute computer teacher in your institution in place of the regular computer teacher referred above for the duration mentioned in the said order by conducting walk-in- interviews.

The teachers will report to the Project Management Unit, Director of Technical Education for the period mentioned above.
