Subject: Instructions to Lead Schools Towards Non - Cancellation of Elective Curriculum Classes

Sir,

The Project Management Unit (PMU) has implemented the Coding and Robotics Education in Schools (CARES) Scheme , Revised ICT Elective Curriculum across 209 Lead Schools for the Academic Year 2025-26.

The Executive Committee - CARES has approved the *Academic Plan* for AY 2025-26 to ensure essential lessons are completed as per the Academic Plan by December 2025.

As you are aware, Lead Schools under the PMU operate in a hub-and-spoke model, wherein students from the Lead School as well as neighbouring schools attend Elective Curriculum post school hours at the premises of the Lead School. Any cancellation of classes at Lead Schools due to internal activities disrupts learning for students from multiple schools and may affect the timely completion of Academic Plan, and hamper the learning outcomes.

 Therefore, it is essential that no Elective Curriculum classes are cancelled henceforth until the mandatory lessons / portion of the syllabus is completed by December 2025.

It is requested that necessary instructions be issued to all Lead Schools to ensure the following:

1. No cancellation of Elective Curriculum classes shall be permitted until 23rd December 2025.

2. Computer Labs to remain open, and adequate support staff to be made available during session timings.


